PROPOSITION SAFE AND SECURE

“Proposition Safe and Secure - In order to meet the critical needs of law enforcement, to ensure the safety and security of Lincoln County residents and provide for the orderly and efficient administration of justice, shall the County of Lincoln impose a county-wide sales tax at the rate of one-half of one percent (1/2 of 1%) for the purpose of expanding, renovating, and maintaining county buildings and properties; which may include the county jail, sheriff’s office, justice center, and emergency communication center?”

The approval of the proposition will authorize the imposition and collection of a one-half of one percent sales tax in addition to the other sales taxes provided for by law on all retail sales made in the County which are subject to taxation.

NON ELECTION DISTRICTS RSMo 115.124.1

The following positions have been filled in accordance with Section 115.124.1 RSMo which states that if the notice of filing provided for in Section 115.127 has been published in at least one newspaper of general circulation in the district and the number of candidates who have filed for a particular office is equal to the number of positions in that office to be filled by the election, no election shall be held for such office, and the candidates shall assume the responsibilities of their offices at the same time and in the same manner as if they had been elected.

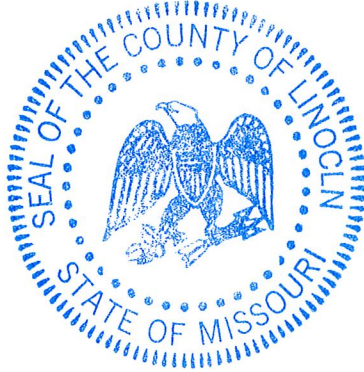
