

**LINCOLN COUNTY ELECTION AUTHORITY'S  
CERTIFICATION OF ISSUES  
AUGUST 6, 2019 SPECIAL ELECTION**

The following is a listing of the propositions that are to be submitted to the qualified voters of the respective districts at the Special Election to be held in the County of Lincoln, State of Missouri on the 6th day of August, 2019, as certified to this office.

**Lincoln County Ambulance District  
Prop Ambulance**

The Lincoln County Ambulance District serves all of the municipalities and unincorporated areas of Lincoln County, Missouri, by providing professionally staffed ambulances that respond to the emergency medical needs of a growing and aging population. In order to save lives and decrease response times due to increasing call volumes and frequency of unavailable emergency ambulances, shall the Board of Directors of Lincoln County Ambulance District be authorized to levy an additional tax of not more than thirty-five cents per one hundred dollars assessed valuation to provide funds for the support of the District?

**CITY OF ELSBERRY  
PROPOSITION NO. 1**

Shall The Board Of Aldermen Of The City Of Elsberry, Missouri Provide By Ordinance For The Appointment Of A City Collector As Provided For By The Statutes Of The State Of Missouri?

**Wright City Fire Protection District  
PROPOSITION S**

Shall the Board of Directors of the Wright City Fire Protection District be authorized to levy an additional tax of not more than seventeen cents (\$0.17) on the one hundred dollars assessed valuation to provide for the support of the District?

The District intends to use the proceeds for the purpose of providing quality emergency services to the community by keeping current staffing levels, maintaining all four fire stations within the District, and ensuring access to appropriate training for its staff.

**School District No. 3 of Warren County, Missouri  
PROPOSITION J**

Shall the Board of Education of the Reorganized School District No. 3 of Warren County, Missouri, be authorized to increase the operating tax levy by \$0.3900 per one hundred dollars of assessed valuation for the purpose of meeting additional operating expenses?

(If this proposition is approved, the adjusted operating tax levy of the District is estimated to increase by \$0.3900 from \$3.5812, currently, to \$3.9712 per one hundred dollars of assessed valuation for the 2019 Tax Year and can be applied to the assessed valuation for each year.)
