The County Commission convened at 9:05 a.m., pursuant to adjournment on March 10, 2014. Present: Dan Colbert-Presiding Commissioner, EuGene Galloway- Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, and Crystal Hall, County Clerk, the following proceedings were held:

Invocation given by Rev. Gary Jackson.

**Jerry Fox, Collector**

- Presented tax affidavits from February for the Commissioners to sign.
- Fox intends to purchase a scanner for \$1,895.00 through the tax maintenance fund. The scanner will be used to archive tax affidavits.

**Sheriff John Cottle**

- There are currently 48 Federal prisoners being housed in the jail. Cottle hopes to house at least 60 Federal inmates by the summer.
- Integrity Steel is scheduled to begin working on the security electronics beginning March 18, 2014.
- Commissioner Bass made a motion to dispose of a vacuum which no longer works, inventory tag# 3189. Commissioner Galloway second. The ayes carried the motion.
- Sheriff Cottle complimented on the job performance of new hire, Clay Stewart. Cottle stated Mr. Stewart is doing a good job cleaning the Sheriff's Office.
- Sheriff Cottle states the software for jail maintenance has been updated and he is looking forward to utilizing the benefits it affords his department.
