

THE APRIL TERM HELD ON THE 13<sup>TH</sup> DAY OF APRIL 2015

The County Commission convened at 9:05 a.m., pursuant to adjournment on April 7, 2015. Present: Dan Colbert-Presiding Commissioner, Matt Bass-Associate Commissioner District 2, and Crystal Hall, County Clerk. Absent: EuGene Galloway- Associate Commissioner District 1, the following proceedings were held:

Invocation given by Commissioner Bass.

**Highway Department:** Bruce Wallace and Don Lilley

- General maintenance issues were discussed.
- Crews continue to work to make roads passable after recent storms and wash outs.
- Discussed striping of roads. Wallace will put together a list of roads that need striping.

**Maintenance Staff:** Sam Clary

- General maintenance issues and work orders were discussed.
- Discussed phone line issues at the Justice Center.

**Unfinished/New Business**

- Troy Mayor Mark Cross asked the Commission to consider a recycle dumpster for County residents. Mayor Cross indicated that the City has two recycle dumpsters at City Hall and they are constantly full. Mayor Cross feels like a majority of the recycling is coming from County residents, and feels like the County having an additional location for recycling would benefit both the City and the County.
- Commissioner Bass made a motion to authorize a change order of \$5,525.80 to Mid River Asphalt, Inc. for concrete changes. Commissioner Colbert second. The ayes carried the motion.

- Commissioner Bass made a motion to approve an updated Emergency Operations Plan for Lincoln County. Commissioner Colbert second. The ayes carried the motion.
- Commissioner Bass made a motion to go into closed session to discuss legal matters. Commissioner Colbert second. A roll call vote was taken, all ayes to enter closed session. Motion carried.
- Commissioner Bass made a motion to leave closed session. Commissioner Colbert second. A roll call vote was taken, all ayes to leave closed session. Motion carried.
