

THE JULY TERM HELD ON THE 24<sup>TH</sup> DAY OF AUGUST 2015

The County Commission convened at 9:05 a.m., pursuant to adjournment on August 18, 2015. Present: Dan Colbert-Presiding Commissioner, EuGene Galloway- Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, and Crystal Hall, County Clerk, the following proceedings were held:

Invocation given by Commissioner Bass.

**Highway Department:** Bruce Wallace

- General maintenance issues were discussed.
- Asphalt repairs have been completed on Quarry and Witt Roads.
- Barricades need to be placed on Sandy Slough Road to indicate road closure.
- Discussed asphalt procedures. New construction is scheduled for Millcreek Church Road and Highland Prairie Road under the cost share program.
- Two mowers and the arm cutter are out on roads today, the Commission requested that 4 flood buy out lots be mowed in Winfield Acres.

**Maintenance Staff:** Randy Siebert, and Bryan Clary

- General maintenance issues and work orders were discussed.
- Randy Siebert will take an inventory of salt for sidewalks and driveways and will call to get prices.

**Unfinished/New Business**

- Jeff Banderet, Great River Engineering discussed the planning phase of the Bunker Hill Bridge and reviewed road damage assessments.
- Commissioner Bass made a motion to enter into multiple agreements with SKW Inc., for professional services for the following: Bridge replacement for an existing low water crossing on Birkhead Road \$47,000.00; bridge replacement for an existing bridge less than 20 feet on Fred Norton Road \$47,000.00; bridge replacement for bridge# 1970015 on Snyder Road \$47,000.00; bridge replacement for bridge# 0310006 on N. Cornerstone Church Road \$47,000.00; bridge replacement for bridge# 1700004 on Holmes Road \$47,000.00; Flood damage repair to 9 bridges: Beck Road, bridge# 3350021; Fred Norton, bridge# 2710001; Jones Road, bridge# 2670013; Mennemeyer Road, bridge# 2790012; N. Rock Church Road, bridge# 2830016; Norton Road, bridge# 1070017; Spielhagen Road, bridge# 2910018; S. Chantilly Road, bridge# 2380014; and Stanek Road, bridge# 1100029 for a lump sum fee of \$36,000.00 for the design and bid phase. Commissioner Galloway second. The ayes carried the motion.
