Invocation given by Commissioner Bass.

**Crystal Hall, County Clerk**

- Commissioner Bass made a motion to approve a single source purchase from Election Administrators, LLC to purchase 38 EA tablet electronic poll books for \$58,710.00. Commissioner Galloway second. The ayes carried the motion.
- Commissioner Bass made a motion to approve entering into a contract with Sprint to purchase wireless communication services under the Western State Contracting Alliance (WSCA) Agreement #1907, and the the WSCA Participating Addendum between Sprint Solutions, Inc., and the State of Missouri. Sprint will provide hotspots and air cards for internet access at polling places. Commissioner Galloway second. The ayes carried the motion.
