

THE JANUARY TERM HELD ON THE 7<sup>TH</sup> DAY OF MARCH 2016

The County Commission convened at 9:05 a.m., pursuant to adjournment on March 1, 2016. Present: Dan Colbert-Presiding Commissioner, EuGene Galloway- Associate Commissioner District 1, Matt Bass-Associate Commissioner District 2, and Crystal Hall, County Clerk, the following proceedings were held:

Invocation given by Commissioner Bass.

**Unfinished/New Business**

- Erik Maninga and Kevin James from MODOT discussed the need for a disaster assistance agreement with the County. Maninga gave a brief update of the Highway 61 safety issues. Discussed the draft of the 5 year construction plan, the Highway 61 bridge over the Cuivre River and the Route H bridge are both expected to be on the schedule to be replaced. Discussed upcoming road closure on Route MM while MODOT replaces bridge.

**Highway Department:** Bruce Wallace

- General maintenance issues were discussed.
- Signs have been stolen from contractor working on Norton Road.
- Crews are cutting trees and preparing for contractors to replace bridges on Cornerstone and Fred Norton Roads.

- General maintenance issues and work orders were discussed.

**Unfinished/New Business**

- Chad Eggen, Boonslick Regional Planning, discussed the potential of CDBG funds to be used to pay for bridge repairs for flood recovery to cover what FEMA does not.
- Commissioner Galloway made a motion to transfer \$59,000.00 soft match credit to Crawford County in exchange for \$59,000.00 of BRO funds. Commissioner Bass second. The ayes carried the motion.
- Clen Industries, Inc. has informed the County that due to recent material price increases, they are unable to renew the sign contract original pricing. The Commission will put a new packet together and put the Highway Department Road Signs out for a new bid process.
