

THE APRIL TERM HELD ON THE 1ST DAY OF APRIL 2019

The County Commission convened at 9:00 a.m., pursuant to adjournment on March 26, 2019. Present: Joseph Kaimann, Presiding Commissioner; Mike Mueller, Associate Commissioner District 1; Matt Bass, Associate Commissioner District 2; and Crystal Hall, County Clerk. The following proceedings were held:

Invocation given by Commissioner Bass.

New Business

- Commissioner Mueller made a motion to approve the revised open session minutes from March 19, 2019. Commissioner Bass second. All ayes to carry the motion.

Highway Department: Eric Tapley

- General road maintenance items were discussed.
- Discussed update on Snyder Road Bridge.
- Discussed flooding procedures including road closures and signs, and sand bagging. Flood gates have been fixed on Gravens Road.
- Commissioner Mueller made a motion to hire Shelly Vrabel at \$14.00 per hour. Commissioner Bass second. All ayes to carry the motion.
- Discussed an update on the new fuel system. The system should be operational by next week.
- Discussed landowner demands for acquiring an easement on Carter Road for future road improvements.
- Reviewed a list of pending and future projects to be completed.
- Commissioner Mueller made a motion to re-open Birkhead Road, effective immediately. Commissioner Bass second. All ayes to carry the motion.

Unfinished/New Business

- The Second Reading for a petition to vacate a portion of Horton Road was read aloud. Commissioner Mueller made a motion to vacate the following portion of Horton Road: "Said Public road commences in the municipal township of Waverly beginning at a stone in the SW corner of Section 22, Township 51 North, Range 2 West of the 5th P.M. Thence S 89 degrees, 33', 00" E along the south line of Section 22 and Section 27, Township 51 North, Range 2 West of the 5th P.M. in Lincoln County, Missouri. The section of road terminates at 89 degrees, 33', 00" W 1,305 feet from an old iron road the S ¼ Corner of Section 22. Commissioner Bass second. All ayes to carry the motion.
- Commissioner Bass made a motion to hire Brian Richardson at \$14.00 per hour. Commissioner Mueller second. All ayes to carry the motion.
