INSTRUCTIONS TO VOTER

To vote you must darken the oval (●) completely. Use only the pen provided.

CANDIDATES:

To vote for a person whose name is printed on the ballot, darken the oval to the left of the name of the person for whom you wish to vote.

WRITE-IN:

To vote for a person whose name is not printed on the ballot, write his or her name in the blank space provided for such purposes and darken the oval to the left of the space. Only a declared write-in candidate is to be counted.

PROPOSITIONS or QUESTIONS:

If you are in favor of the proposition or question darken the oval opposite the word "YES". If you are opposed to the proposition or question, darken the oval opposite the word "NO".

SPOILED BALLOT:

If you spoil the ballot or make an error, you may return it to an election judge and receive another. The election judge shall mark "SPOILED" across the ballot and place it in an envelope marked "SPOILED BALLOTS" and then give you another ballot.

SPECIAL SCHOOL BOND ELECTION
ELSBERRY R-II SCHOOL DISTRICT
PROPOSITION 2

Shall the Board of Education of the Elsberry R-II School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Five Hundred Thousand Dollars (\$2,500,000) for the purpose of providing funds to complete renovations that provide for safe and secure entrances at the high school, middle school, elementary school, and administrative offices; renovate District bathrooms; upgrade the heating, ventilation, and air condition (HVAC) system and light fixtures at the Agriculture Building; repave the parking lot; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.3806 per one hundred dollars of assessed valuation of real and personal property.
