INSTRUCTIONS TO VOTER

To vote you must darken the oval ( ● ) completely. Use only the pen provided.

CANDIDATES:

To vote for a person whose name is printed on the ballot, darken the oval to the left of the name of the person for whom you wish to vote.

WRITE-IN:

To vote for a person whose name is not printed on the ballot, write his or her name in the blank space provided for such purposes and darken the oval to the left of the space. Only a declared write-in candidate is to be counted.

PROPOSITIONS or QUESTIONS:

If you are in favor of the proposition or question darken the oval opposite the word "YES". If you are opposed to the proposition or question, darken the oval opposite the word "NO".

SPOILED BALLOT:

If you spoil the ballot or make an error, you may return it to an election judge and receive another. The election judge shall mark "SPOILED" across the ballot and place it in an envelope marked "SPOILED BALLOTS" and then give you another ballot.

SPECIAL SCHOOL LEVY ELECTION  
PIKE COUNTY R-III SCHOOL DISTRICT  
PROPOSITION 2

Shall the Board of Education of the Pike County R-III School District, Missouri, be authorized to increase the operating tax levy ceiling by \$0.3300 to \$4.2515 per one hundred dollars of assessed valuation in order to provide additional funds to maintain its facilities and meet the operating expenses of the District?

The District intends to reduce the debt service levy by \$0.3300 per one hundred dollars of assessed valuation in order to offset the estimated \$0.3300 per one hundred dollars of assessed valuation increase to the operating levy and will result in no net increase to the total tax levy if this Proposition is approved by the voters. Approval of this proposition increases the District's operating tax levy ceiling to \$4.2515 per one hundred dollars of assessed valuation and will be applied to the assessed valuation in tax year 2018 and each year thereafter.
